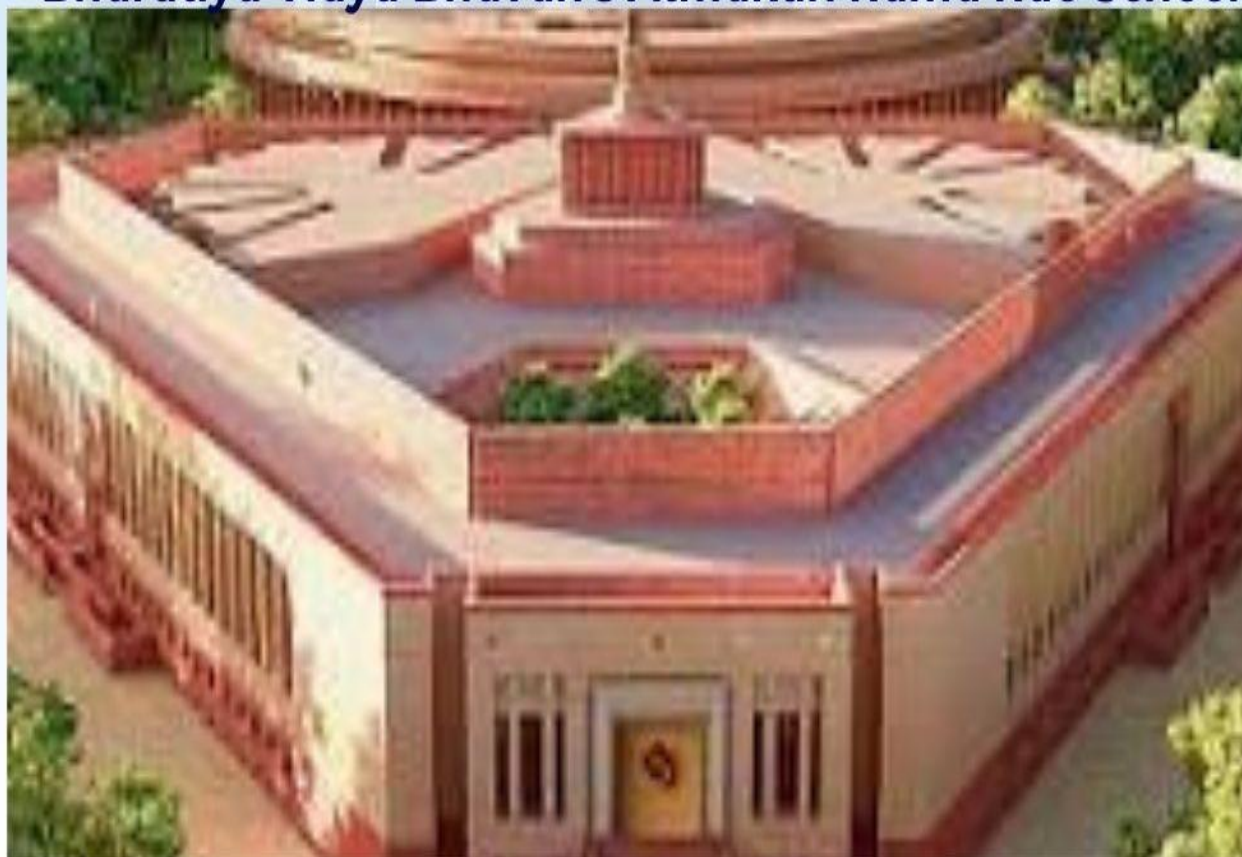

RULES AND REGULATIONS

Eligibility for entry into the Competition Grades IX - XII

Format and Period of the Competition

Each school would be allocated a time span of 20 minutes. The proceedings of the session should include:

1. Question Hour
2. Bills and Motions
 - Introduction and Reading of the Bill
 - Proposal for a new bill towards nation-building.
 - 2nd Reading and general provisions of the Bill
3. Passing the vote to the bill
4. Adjournment
 - Formal closing of the session
5. Questions by the Press (only 2 Questions)

Kindly note:

All props and costume requirements to make the Parliament session effective are to be brought by the respective schools.

Dress Code:

As per the Parliamentary norms

- Girls - Sarees
- Boys - Kurta Pyjama/Dhoti
- Press reporters to carry a badge displaying the School name

Discipline:

- Audience schools should not hamper the proceedings of the Parliament.
- Such a situation would call for a deduction in the points awarded.

The prizes to be won under the following categories:

- Best Parliament session
 - a. 1st Position
 - b. 2nd Position
 - c. 3rd Position
- 2. Best Debater
 - a. 1st Position
 - b. 2nd Position
- 3. Best Individual Portfolio
- 4. Best Press Reporter

MANDATES FOR THE MODEL PARLIAMENT

Procedures and practices to be followed in the Model Parliament should correspond as far as possible to the practices and procedures followed in the Lok Sabha.

Do's and Don'ts of Model Parliament:

1. The subject to be selected for discussions in the Model Parliament Competitions should be as far as possible non-controversial.
2. A Model Parliament group should comprise a minimum number of 14 and maximum 18 participants which would include **a Speaker, a Marshal, a Press correspondent and a maximum of 5-8 portfolio holders.**

The list of the portfolios is given below:

- Minister of Home Affairs
- Minister of Agriculture and Farmers Welfare
- Minister of External Affairs
- Minister of Road Transport and Highways
- Minister of Environment, Forest and Climate Change
- Minister of Defence
- Minister of Law and Justice
- Minister of Health and Family Welfare
- Minister of Women and Child Development
- Minister of Labour and Employment
- Minister of Human Resource Development
- Minister of Social Justice and Empowerment
- Minister of Consumer Affairs, Food and Public Distribution
- Minister of Finance
- Minister of Civil Aviation
- Minister of Chemicals and Fertilizers

A Bill for presentation can be chosen from the list given below along with a new bill proposed towards nation-building (Innovative Idea):

- The Occupational Safety, Health and Working Conditions Code, 2019
- The Wildlife (Protection) Amendment Bill, 2022
- The Immigration and Foreigners Bill, 2025
- Women's Reservation Bill, 2023 (The Constitution 128th Amendment Bill)
- The Union Territories Laws (Amendment) Bill, 2024
- The Protection of Interests in Aircraft Objects Bill, 2025
- The Disaster Management (Amendment) Bill, 2024
- The participants should scrupulously avoid mentioning the existing political parties and political personalities in the country. They should give imaginary or fictitious names to their parties and personalities.

- They should not give any impression that they have any leanings or bias for or against any political party or philosophy.
- Every member while coming to the House for its sitting should bow to the Chair and similarly while leaving the chamber bow to the Chair.
- No member should read out a written speech. However, a member may feel free to consult his/her notes whenever he/she loses track of his/her prepared speech or text.
- The members participating in the discussion can use either English or Hindi.
- In short, all participants in these Model Parliaments should so conduct themselves as to inspire respect for the Parliament and Parliamentary Institutions.

The performance of the schools will be judged based on the following Parameters:

1. Validity of questions/Clarity
2. The proposed new bill
3. Decorum
4. Ability to debate
5. Interesting add on/Props /Costumes
6. Rebuttal
7. Adherence to guidelines
