- 9) In view of the above the Occupancy <u>Fire No Objection Certificate</u> is issued subject to the following Conditions.
- i. The NOC issued is confined to the Fire Safety measures installed in the building and does not confer any Legal right for claiming of Ownership of property or Conversion of land use/Occupancy or Building Regularization. The Owner/ Occupier shall comply the Building Rules/Govt.Orders as applicable.
- ii. Fixed and First-Aid Fire Fighting equipment, Alarm System etc, shall be tested and maintained regularly as per applicable standards.
- iii. Temporary structure such as Tents thatched roof construction should not be allowed for educational institutions.
- iv. Emergency Power Generator etc. and associated equipment should be verified periodically as per NBC, and IS-1646.
- v. Every Room occupied with a capacity of 45 students shall be provided with obstruction free minimum two doorways.
- vi. The Builder/Occupier should facilitate periodical inspection by jurisdiction Station Fire Officer and District Fire Officer.
- vii. Evacuation plan showing exit routes and recommended action plan be displayed at conspicuous locations shall be exhibited at all times, all Escape/Exit routes shall not be locked or encroached.
- viii. Fresh Fire NOC would be required for any change in occupancy as per NBC and building bye/laws.
- ix. The School Management has to maintain Fire Fighting Installation at all times in good working condition as seen during the inspection.
- x. Any loss of life or property due to Non-functioning of the Fire Safety Measures and other Installations shall be the responsibility of the Management/Owner.
- xi. All the Occupants must know the correct method of operation of the Fire Fighting System installed.
- xii. Addition/Alterations if any, in the building may be verified by building authority.
- xiii. The Fire Drills shall be conducted once in every Six months for initial two years, thereafter once in every year.

- xiv The Fire No Objection Certificate is valid for 05 years from the date of issue
- xv The issuing of Fire No Objection Certificate is without any prejudice to the action taken by the GHMC against Unauthorized Construction, if any made.
